The Definitive Map and Statement of Public Rights of Way in Hertfordshire

Hertfordshire County Council (Hitchin 42) Modification Order 2022

This Order is made by Hertfordshire County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement of Public Rights of Way in Hertfordshire require modification in consequence of the occurrence of an event specified in Section 53(3) (c)(ii) and (iii) of the Act, namely:

- (c) the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows
- (ii) that a highway shown in the map and statement as a highway of a particular description ought to be there shown as a highway of a different description; and
- (iii) that there is no public right of way over land shown in the map and statement as a highway of any description, or any other particulars contained in the map and statement require modification.

The authority has consulted with every local authority whose area includes the land to which the Order relates.


Hertfordshire County Council hereby order that:

- 1. For the purposes of this Order the relevant date is 1st January 2022.
- 2. The Definitive Map and Statement of Public Rights of Way in Hertfordshire shall be modified as described in Part I and Part II of the Schedule and shown on the plan forming part of this Order ("the Order Plan").
- 3. This Order shall take effect on the date it is confirmed and may be cited as the Hertfordshire County Council (Hitchin 42) Modification Order 2022.

PART I Modification of Definitive Map

DESCRIPTION OF PUBLIC RIGHT OF WAY TO BE UPGRADED

Part of Hitchin Footpath 42 to be upgraded to a restricted byway commencing from Road off Charlton Road (public highway, formerly known as Mill Lane) at TL 1784 2799 (point A on the Order Plan) then south west along the track for approximately 25 metres to the field boundary at TL 1783 2797 (point B on the Order Plan).

Width:

Varies between 4 and 5 metres between TL 1784 2799 (point A on the Order Plan) and TL 1783 2797 (point B on the Order Plan) as shown excluded from hereditaments on the 1910 Finance Act Map and shaded grey on the Order Plan.

Limitations: None

VARIATION OF PARTICULARS OF PATH OR WAY

The Statement for Hitchin 42 shall be amended as follows:

Commences as RB from Road off Charlton Road (public highway, formerly known as Mill Lane) at TL 1784 2799 then SW along the track for approx 25m to the field boundary at TL 1783 2797 then continues as FP past junction with FP 93 to join Maydencroft Lane at parish boundary at Well Head.

Width Varies between 4m and 5m between TL 1784 2799 and TL 1783 2797 as shown in the Hertfordshire County Council (Hitchin 42) Modification Order 2022

Limitations None between TL 1784 2799 and TL 1783 2797
