The Register of interests is maintained by the Monitoring Officer at North Hertfordshire Council in accordance with section 29 of the Localism Act 2011. It is a Councillor's responsibility to notify the Monitoring Officer of their interests and keep the Register up to date within 28 days of election or appointment or of any changes.<sup>1</sup>

<p><b>1. Employment, office, trade, profession or vocation</b> Any employment, office, trade, profession or vocation carried on by you or a relevant person for profit or gain (includes any payments or benefits in kind).</p>

<p><b>2. Sponsorship/ other payments received in respect of your role as a Councillor</b> Any payment or provision of any other financial benefit made or provided within the last <b>12 months</b> in respect of any expenses incurred by you in carrying out duties as a Councillor or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992. You are <b>not</b> required to declare allowances or expenses received from your Council on this form.</p>


