The Hospital Trust I work for is Bedfordshire Hospitals NHS Trust, they are an NHS Trust and a public body in Bedfordshire. I am a Manager within the Hospitals Trust, but have no Director responsibilities.

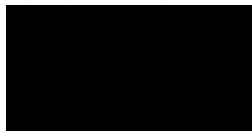
I have noted that it can be a criminal offence under the Localism Act 2011 and a potential breach of my Council's Code of Conduct to:-
