4. REASON FOR DECISION

- 4.1 The tender process managed via intend was led by our consultant Stevenage Borough Council, with the assistance of North Hertfordshire District Council's (NHDC) Procurement Officer, Legal Services and Property Services.
- 4.2 A full procurement process was undertaken and assessed based on 20% quality and 80% price. This determined that Cemplas Waterproofing Ltd offered the most economically advantageous tender.

5. ALTERNATIVE OPTIONS CONSIDERED

5.1 None – the existing car parks due to their age require extensive repairs as identified in the condition survey.
